



AGREEMENT ON COOPERATION

Between

CHERNIHIV POLYTECHNIC NATIONAL UNIVERSITY

And

ST. ELIZABETH UNIVERSITY OF HEALTH AND SOCIAL WORK

1. Subject of a contract

- 1.1. The parties of this agreement intend to cooperate and exchange experience in the following areas:
- training of specialists;
- using of modern methods of teaching and learning technologies in the educational process;
- organizing virtual internships for students;
- exchanging of training programs and staff retraining and refreshment courses;
- exchanging of information about the scientific seminars, conferences and other activities organized by the parties;
- organizing of joint conferences, seminars and other activities:
- assistance in the publication of scientific papers in the territory of Slovakia and Ukraine:
- searching for sources of funding (grants) to carry out research work.
- 1.2. In the cases of necessity, including the ones not mentioned by this contract, the parties may conclude other agreements or contracts.

2. Financial conditions

- 2.1. This contract is an agreement of intent and does not impose financial obligations to any parties.
- 2.2. Relationships between the parties providing for any financial obligation are issued in the form of individual agreements (contracts).

3. Privacy

3.1. The Parties shall ensure the confidentiality of documents and information that must remain confidential according to a mutual decision.

4. Adjustment of disputes

- 4.1. All disputes that may arise under this Agreement, the parties shall endeavor to resolve by negotiation.
- 4.2. When the settlement of disputes by negotiation is not possible, this contract shall be considered terminated.

5. Duration of the agreement and the procedure for amending

- 5.1. The Agreement shall enter into force on the date of its signature and shall be valid for five years. In case of expiry date, if any of the parties does not wish to terminate the contract, the contract validity is automatically extended for other 5 years.
- 5.2. All changes and addendums to this Agreement are agreed by the representatives of the parties, shall be in writing in duplicate and after being signed by the parties are considered an integral part of this contract.

6. Miscellanea

6.1. This Agreement is made in English and signed by the parties in two copies, one for each party.
